

Resolution No. 2014 – 08

**A RESOLUTION OF THE GOVERNING BODY OF THE CITY OF
HILLSBORO, KANSAS, REGARDING THE USE OF THE DOWNTOWN AREA
FOR THE PURPOSE OF THE ANNUAL ARTS AND CRAFTS FAIR AND
REPEALING FORMER RESOLUTION –2011-02A**

Whereas, the city of Hillsboro, Kansas supports the efforts of Hillsboro Arts and Crafts Association in promoting and producing the annual Arts and Crafts Fair; and,

Whereas, the city of Hillsboro, Kansas recognizes the Association's desire to choose concessions that will benefit Hillsboro, that is, those who are interested in serving the public and following rules.

Now therefore be it resolved by the governing body of the city of Hillsboro, Kansas as follows:

Section 1. The governing body hereby grants permission to the Hillsboro Arts and Crafts Association to use the downtown area for the purpose of providing the annual Arts and Crafts Fair. This includes the center of the street and the sidewalk city easement area in the seven blocks of exhibits as follows:

- North Main, Grand, north to 2nd St.
- South Main, Grand Avenue south to B street
- E. 1st St., south side of street (for dumpsters and trash truck). North. Main Exhibits drive into North Main from 1st Street. This is also a loading place later in the day for furniture purchases.
- West Grand, block one, from Main Street to Ash, into second block south side of street up to residential driveway.
- East Grand, block one from Main Street to Washington.
- East Grand, block two from Washington to Lincoln.
- East Grand, block three, for artists parking on both sides of the street.

There are six points of entry to the seven blocks of the Fair. It is the responsibility of the Arts and Crafts Association to keep these points of entry clear of any obstruction during the hours of 5 PM Friday to 8 PM on the day of the fair.

Time: Each third Friday and Saturday of September, from 5:00 PM on Friday through 8 PM on Saturday. This includes the actual time of the fair on Saturday, 9 AM to 4:00 PM, marking the streets at 5 PM and the artists set up time beginning at 7 PM Friday.

Section 2. The Governing Body of the city of Hillsboro, Kansas also gives the Hillsboro Arts and Crafts Association the jurisdiction over all art exhibits and concessions as chosen by their jurors, and placed in the fair area.

Section 3. This resolution shall take effect and be in full force from and after its adoption by the governing body of the city of Hillsboro Kansas.
