ORDINANCE NO. 1364

AN ORDINANCE OF THE CITY OF HILLSBORO, KANSAS ADOPTING CHAPTER 14, ARTICLE 2, SECTION 14-211 OF THE CODE OF THE CITY OF HILLSBORO, KANSAS.

WHEREAS, the governing body of the City of Hillsboro, Kansas (the "City") has previously adopted Chapter 14, Article 2 of the Code of the City of Hillsboro, Kansas (the "Code"), which contains provisions establishing local traffic regulations; and

WHEREAS, the City finds it necessary to adopt Chapter 15, Article 2, Section 14-211 of the Code.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HILLSBORO, KANSAS:

Section 1. Chapter 14, Article 2, Section 14-211 is hereby adopted as follows:

**14-210. Designated Downtown Parking**

(a) The governing body may, by resolution, designate any parking space(s) located Downtown for the exclusive use of a building or business located Downtown as the governing body determines necessary to promote safety and accessibility and may establish and fix the location of such parking control devices as may be deemed necessary to inform the public of such exclusive use. The city shall place and maintain such traffic control signs, signals and devices when and as may be required by the authority of the governing body to make effective the provisions of this chapter and other ordinances for the regulation of parking.

(b) For purposes of this Section, "Downtown" means the area within the City bounded by Ash Street on the West, B Street on the South, Washington Street on the East, and 2<sup>nd</sup> Street on the North.

(c) The provisions regarding, Citation on Illegally Parked Vehicles, Failure to Comply with Traffic Citation Attached to Parked Vehicles, and the Presumption in Reference to Illegal parking as set forth in the City's Standard Traffic Ordinances for Kansas Cities published by the Kansas League of Municipalities then in effect shall apply.

(d) Violation of any part of this section shall be an ordinance traffic infraction. Upon entry of a plea of guilty or no contest or upon being convicted of such violation, the penalty imposed on a first offense shall be a fine of Twenty-five Dollars (\$25); on a second offense within six (6) months a fine of Fifty Dollars (\$50); and on a third or subsequent offense within six (6) months a fine of One Hundred Dollars (\$100).


Section 2. This Ordinance shall take effect and be in full force from and after its adoption by the Governing Body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.
