A RESOLUTION FIXING A TIME AND PLACE AND PROVIDING NOTICE OF A PUBLIC HEARING BEFORE THE GOVERNING BODY OF THE CITY OF HILLSBORO, KANSAS, AT WHICH THE OWNERS, THEIR AGENTS, ANY LIENHOLDERS OF RECORD AND ANY OCCUPANTS OF THE STRUCTURE LOCATED ON THE PREMISES DESCRIBED HEREIN, MAY APPEAR AND SHOW CAUSE WHY SUCH STRUCTURE SHOULD NOT BE CONDEMNED AND ORDERED REPAIRED OR DEMOLISHED AS A PUBLIC NUISANCE, DANGEROUS OR UNSAFE STRUCTURE.

SECTION 1. <u>Acceptance of the Statement</u>. The statement of the City's enforcing officer dated June 2, 2022 is hereby accepted by the City.

SECTION 2. <u>Public Hearing</u>. A public hearing will be held on the 6th day of September, 2022 before the Governing Body of the City at 6:30 p.m., at City Hall, 118 E. Grand Avenue, Hillsboro, Kansas 67063, in the City Council room, at which time and place the owners, their agents, any lienholders of record and any occupants of the structure located at the following premises:

and (ii) within three days of its first publication, mail a copy of this Resolution by certified mail to the owners, agents, lienholders of record and occupants at the last known address, marked "deliver to addressee only."
