# Ordinance No. 1260

## AN ORDINANCE RELATING TO ELECTRIC RATES, AMENDING SECTIONS 17-216.1,17-217.1, 17-218.2 AND 17-218.3 OF THE CODE OF THE CITY OF HILLSBORO, KANSAS AND REPEALING ORDINANCE NO. 1240a.

## BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HILLSBORO, KANSAS:

- **SECTION 1.** That section 17-216.1 of the Code of the City of Hillsboro, Kansas is hereby amended to read as follows:
- 17-216.1 RESIDENTIAL RATES AND COMMERCIAL RATES
  - a. Monthly Rate: \$0.11580 per KWH
  - Base Charge: \$9.00 per month. In the event the same customer orders a disconnection or reconnection of electric service at the same premises within a period of twelve (12) months, the City shall collect as a reconnection charge the sum of such minimum bills as would have accrued during the period of disconnection.
- **SECTION 2.** That section 17-217.1 of the Code of the City of Hillsboro, Kansas is hereby amended to read as follows:

## RESIDENTIAL RATES OUTSIDE CITY LIMITS

- *a.* Monthly Rate:
  - i. \$0.11580per KWH for first 4,000 KWH
  - ii. \$0.12000per KWH for all over 4,000 KWH
- Base Charge: \$9.00 per month. In the event the same customer orders a disconnection or reconnection of electric service at the same premises within a period of twelve (12) months, the City shall collect as a reconnection charge the sum of such minimum bills as would have accrued during the period of disconnection.

#### SECTION 3. That section 17-218.2 shall read as follows:

#### 17-2182 TEMPORARY SERVICE.

- *a.* Temporary service means use of electricity of temporary purposes. Services connected for short periods of time, not to exceed 90 days.
- b. Rate
  - i. \$15.00base charge per month
  - ii. \$0.11580per KWH usage

SECTION 4 that section 17-218.3 of the Code of the City of Hillsboro, Kansas shall read as follows:

Any individual or business owner who wishes to have a street light that benefits private

property shall pay a monthly charge as follows:

i.	175 W Mercury Vapor	\$20.00
 11.	250 W Mercury Vapor	\$22.00
 111.	100 W High Pressure Sodium	\$18.00
iv.	250 W High Pressure Sodium	\$22.00
v.	400 W High Pressure Sodium	\$27.00

**SECTION 5.** This ordinance shall take affect and be in force after publication in the "Hillsboro Star Journal," the official city newspaper; provided, however the rates here inset forth shall apply to usage after such publication and to be reflected on the regular June 1 2015 billings
