## **ORDINANCE NO. 1305**

AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF HILLSBORO, KANSAS; INCORPORATING BY REFERENCE THE "2019 STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES", 47th EDITION; PROVIDING CERTAIN PENALTIES; REPEALING SECTION 16-101 OF THE CODE OF THE CITY OF HILLSBORO, KANSAS, PERTAINING TO THE 2018 EDITION OF THE STANDARD TRAFFIC ORDINANCE; REPEALING ORDINANCE NO. 1292; AND CONFIRMING ALL OTHER PROVISIONS OF CHAPTER XVI OF SAID CODE OF THE CITY OF HILLSBORO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HILLSBORO, KANSAS:

Section 1. Incorporating Standard Traffic Ordinance 16-101. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Hillsboro, Kansas, that certain standard traffic ordinance known as the "2019 Standard Traffic Ordinance for Kansas Cities", 47th Edition, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1305", and to which shall be attached a copy of this ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge and all administrative departments of the City charged with enforcement of the ordinance shall be supplied, at the cost of the City, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be deemed expedient.

Section 2. Other Provisions Regulating Traffic and Use of Streets under Chapter XVI; Penalty; All other provisions of Chapter XVI of the Code of the City of Hillsboro, Kansas, shall remain in full force and effect. Violations of traffic ordinances set forth in Chapter XVI not otherwise covered by the "2019 Standard Traffic Ordinances for Kansas Cities, 47th Edition" shall be treated as an unscheduled offense under Section 201(d) of said Standard Traffic Ordinance.

<u>Section 3. Repeal of Prior Standard Traffic Ordinances.</u> Previous "Standard Traffic Ordinance for Kansas Cities, edition of 2018" is hereby repealed. (16-101) The enacted revision shall be substituted at 16-101.

<u>Section 4. Effective Date.</u> This ordinance shall take full force and effect from and after its publication one time in the *Hillsboro Star Journal*, the official City newspaper.
