ORDINANCE NO. 1299

AN ORDINANCE AMENDING ORDINANCE NO. 1289 (AS PREVIOUSLY AMENDED BY ORDINANCE NO. 1298) OF THE CITY OF HILLSBORO, KANSAS.

WHEREAS the governing body of the City of Hillsboro, Kansas (the "City") previously adopted Ordinance No. 1289 on August 7, 2018 and published on August 15, 2018, as amended by Ordinance No. 1298 adopted on June 18, 2019 and the summary of which was published on June 26, 2019 (collectively, the "Original Ordinance") which Original Ordinance designated main trafficways and authorized the repair of certain streets in the City (the "Project") at an estimated cost of \$3,200,000; and

WHEREAS, the City has now received construction bids on said Project and the ultimate known costs of the Project are \$4,075,000; and

WHEREAS, in connection with the foregoing, the governing body of the City finds and determines it advisable to supplement and amend the Original Ordinance of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HILLSBORO, KANSAS:

Section 1. <u>Amendment to Sections 2 and 3 of Ordinance No. 1289</u>. Sections 2 and 3 of the Ordinance No. 1289 is hereby amended by deleting Sections 2 and 3 and replacing them with the following:

Section 2. <u>Payment of Project Costs</u>. It is hereby further found and determined that the estimated cost of construction of the Project is \$4,075,000 which shall be payable by the City-at-Large and paid through the issuance of general obligation bonds of the City.

Section 3. <u>Authorization of the Bonds</u>. It is hereby further found and determined to be necessary and it is hereby authorized, ordered and directed that in order to provide the necessary funds to pay the cost of the Project, there shall be issued general obligation bonds in the estimated principal amount of \$4,075,000.

Section 3. <u>Amending Ordinance</u>. This ordinance supplements and amends the Original Ordinance only to the extent necessary to increase estimated cost for the Project. Except to the extent specifically amended hereby, Ordinance Nos. 1289 and 1298 shall remain in full force and effect.
