ORDINANCE NO. 1331

AN ORDINANCE AMENDING SECTION 3-104 OF CHAPTER III, ARTICLE 1 OF THE CODE OF THE CITY OF HILLSBORO, MARION COUNTY, KANSAS RELATING TO CONSUMPTION OF ALCOHOLIC LIQUOR ON CITY OWNED PROPERTY.

WHEREAS, the City of Hillsboro, Kansas (the "City") has previously adopted Chapter III, of the Code of the City of Hillsboro, Kansas (the "Code"), which contains provisions regulating beverages; and

WHEREAS, the Governing Body of the City desires, and finds it necessary and advisable to amend Section 3-104, Chapter III, Article 1 of the Code to allow consumption of alcoholic liquor on the City's fairgrounds, commonly known as the Hillsboro Fairgrounds.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HILLSBORO, KANSAS:

SECTION 1. Chapter III, Article 1, Section 3-104 of the Code shall be amended and replaced and shall read as follows:

3-104. Consumption on public property.

No person shall drink or consume any alcoholic liquor on city owned public property. However, this prohibition shall not apply to the following, which is property owned by the city:

The property commonly called the Hillsboro Municipal Golf Course, with a legal description of: Beginning at the Southeast corner of the Northwest Quarter of Section 4, Township 20 South, Range 2 East of the 6th P.M., Marion County, Kansas, thence North 2,170 feet, thence Southwesterly along the center line of an existing waterway drainage ditch 940 feet; thence Northwesterly along the North course of said drainage ditch, Northwesterly 1,100 feet, thence West to the North-South center line of said Quarter Section; thence South 2,350 feet more or less, along the centerline, to the South line of the Quarter; thence East 1,320 feet to place of beginning; and.

The property commonly called the Hillsboro Fairgrounds, with a legal description of: A TRACT OF LAND IN THE NORTHEAST QUARTER OF SECTION 4, TOWNSHIP 20 SOUTH, RANGE 02 EAST, IN MARION COUNTY, KANSAS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF THE NORTHEAST QUARTER OF SECTION 4, TOWNSHIP 20 SOUTH, RANGE 02 EAST;

THENCE EAST 1107 FEET ALONG THE NORTH LINE OF SAID SECTION:

THENCE SOUTH 33 FEET TO THE SOUTH RIGHT OF WAY LINE OF D STREET, WHICH IS THE POINT OF BEGINNING AND THE NORTHEAST CORNER OF THE SWIMMING POOL LOT:

THENCE CONTIUNING SOUTH 207 FEET ALONG THE EAST LOT LINE OF THE SWIMMING POOL LOT;

THENCE WEST 101.52 FEET ALONG THE SOUTH LINE OF THE SWIMMING POOL LOT;

THENCE S 1°9'28.0" E, PARALLEL TO THE EAST LINE OF SAID SECTION, 626.0 FEET:

THENCE N 89°5'1.4" E, PARALLEL TO THE NORTH LINE OF SAID SECTION, 329.04 FEET;

THENCE N 0°34'46.9" E, 570.14 FEET;

THENCE N 89°14'30.2" E, 116.17 FEET;

THENCE S 24°14'25.8" E, 101.18 FEET;

THENCE S 43°5'17.1" E, 181.90 FEET;

THENCE S 69°39'37.7" E, 215.09 FEET:

THENCE N 89°57'15.8" E, 149.08 FEET;

THENCE N 0°2'44.2" W, 30.00 FEET;

THENCE S 89°57'15.8" W, 98.00 FEET;

THENCE N 0°2'44.2" W, 52.74 FEET;

THENCE N 48°22'22.5" W, 38.82 FEET;

THENCE N 30°53'30.0" W, 45.36 FEET;

THENCE N 16°24'5.8" W, 92.91 FEET;

THENCE N 1°9'28.0" W, 332.54 FEET TO A POINT ON THE SOUTH RIGHT OF WAY LINE OF D STREET;

THENCE S 89°2'54.3" W, ALONG THE SOUTH RIGHT OF WAY LINE OF D STREET, 696.03 FEET TO THE POINT OF BEGINNING.

SECTION 2. This Ordinance shall take effect on and be in full force after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.
