

**ORDINANCE NO. 1255**

AN ORDINANCE ANNEXING LAND TO THE CITY OF HILLSBORO, KANSAS

WHEREAS, the following described land is located in Marion County, Kansas; and

WHEREAS, the following described land meets one or more of the conditions prescribed by K.S.A. 12-520(a)(1)-(6); and

WHEREAS, the Governing Body of the City of Hillsboro, Kansas, finds it advisable to annex such land.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF HILLSBORO, KANSAS:

**Section 1.** That the following described land, meeting the conditions for annexation prescribed in K.S.A. 12-520, is hereby annexed and made a part of the City of Hillsboro, Kansas:

**TRACT 1:** (as shown in Book 367, Page 621) A tract of land in the Northeast Quarter (NE/4) of Section 34, Township 19 South, Range 2 East more particularly described as follows:  
Commencing at the NW corner, NE ¼ Sec. 34, T19S, R2E of the 6<sup>th</sup> P.M., thence south along the west line of the NE ¼ of said Sec. 34 a distance of 970' to the point of beginning; thence east a distance of 240.2 feet; thence south 100 feet; thence west 240.2 feet to the west line of the NE ¼ of Sec. 34; thence north 100 feet to the point of beginning.

**TRACT 2:** (as shown in Book 359, Page 504) Commencing at the Northwest Quarter (NE/4) of Section Thirty-four (34), Township Nineteen (19) South, Range Two (2) East of the 6<sup>th</sup> P.M., thence South along the West line of said Quarter a distance of 1070 feet, thence East a distance of 240.2 feet to the place of beginning; thence East 30 feet; thence South and parallel to the Quarter section line a distance of 650 feet; thence West a distance of 30 feet; thence North to the place of beginning.

**Section 2.** Such land is owned by the City of Hillsboro; lies upon or touches the City Boundary Line immediately North (tract 1) and East (tract 2) of the Water Treatment Plant.

**Section 3.** That this ordinance shall be effective from and after its passage, approval and publication in the official city newspaper.
