Re: 2023 Annual Report

The attached is the proposed 2024 budget for the Land Bank which details all the revenue and expenses of the land bank for 2022-23. According to Ordinance 1317, the City Council must approve the Land Bank budget before it can be adopted by the Land Bank board, even though they are the same board.

Revenue and expense detailed reports are attached. On the revenue side, the Land Bank received revenue in the form of rental payments for the farm ground and buildings owned by the Land Bank. Rental payments totaled \$20,224 in 2023. The Land Bank also sold property to Chuck Maltbie for future expansion of his spa business, Larry Smith to construct additional storage units, Hillsboro Ford for the lot at 128 S Main, ELCON Properties LLC for future development, and the Funks for a home build at 211 Willow Glenn. The total revenue from sales was \$35,250.

For expenditures, the Land Bank spent \$36,181.70 on contractual expenditures which includes mowing expenses, repair of the welding school heaters, and roof repair at the AMPI building. Utilities for Land Bank buildings were \$4,114.91. Commodities for the Land Bank included "For Sale" signage, Platting Services from EBH, Deed filling fees, and \$13,010.45 in property taxes. The property tax bill is in dispute as Land Bank properties are to be tax exempt.

In the 2024 budget, the starting unencumbered balance is \$64.09. Rental income is projected to be \$19,000. Property sales for 2024 are projected at \$20,000 based historical trend and efforts to develop property. Expenditures are similar to 2023 less \$18,181.70 that was for repair of roofs and heaters that should not be reoccurring. Property taxes are being reviewed by Marion County now for a determination.

The Land Bank also holds the property proposed to be used by Mennonite Housing for a 24-unit development called Orchard Ridge. The initial tax credit application for Orchard Ridge has been submitted to the Kansas Housing Resource Corporation. If selected for tax credits, then the project would move forward in mid-2024 and open in 2025.

The attached spreadsheet details the listing of property that the Land Bank holds. The list will also be published on the city website as per state law.

**Recommendation**: There are two actions that need to happen. First to formally approve the 2024 budget (assuming it was approved by the City Council). Second, formally accept the 2023 Annual Report.
